A motion made by Mr. Brookins and seconded by Ms. Bentley to hire Dematio Seal Coating to fill cracks on all city streets in the amount of \$10,800.00 (ten thousand eight hundred dollars 00 cents) Ayes: All. Motion carried.

A motion made by Mr. Card and seconded by Ms. Bentley to hire Pittsburgh Tank and Tower to repair the water tower at a cost of \$22,500.00 (twenty-two thousand five hundred dollars 00 cents). Ayes: All. Motion carried.
